**20. DEPARTMENT (s):**

1. The managing Trustees after a resolution taken by full majority of the board of trustees, will established personnel department with all amenities and office bearers with a view to appoint staff(s)/Teacher(s) officer(s) etc. as per needs time to time.
2. The Board of Trustees will establish an expert interview committee, examination board, evaluation board, or any other board or committee as per needs of time for promotion of its functions.
3. The Board of Trustees can establish the various departments as per needs time to time and can frame rules and regulations for such department (s) to carry out the business under this bylaw to achieve goals of the said Trust.

**21. INDEMNITY:**

The Board of Trustees shall be indemnified for any act done by them in good faith in the course of the administration of the trust.

**22. APPLICABILITY OF TRUST ACT:**

The provisions of the Indian Trust Act 1882, amended time to time , shall apply to all matters not specifically mentioned in these presents.

**23. APPLICATION OF INCOME TAX ACT:**

All clause herein are intended to secure exemption from income Tax on the income of contributions and donations to the Trust and any clause or portion of this Deed of Trust which is inconsistent will or repugnant to the sections of the Income Tax Act , 1961 as amended, substituted or modified from time to time, shall be deemed to be deleted or modified with effect from the date on which the sections to which the clause or part of a clause is repugnant or inconsistent comes into force.

**24. DISSOLUTION:**

In the event of dissolution of winding up of the Trust the assets of the Trust remaining on the date of dissolution shall under no circumstance be distributed among the Trustees, but the same shall transferred to other Trust, Society , Association or Institution whose object are similar to those of this Trust.
